

## **OFFICE STYLE YOUR AIR COMPETITION TERMS & CONDITIONS**

These are the official Terms and Conditions (the “**T&Cs**”) of the OFFICE STYLE YOUR AIR competition (the “**Competition**”) and may be amended or updated by OFFICE at any time. The current version of the T&Cs shall be made available on [www.office.co.uk](http://www.office.co.uk).

### **1. WHO IS SPONSORING THE COMPETITION?**

The Competition is sponsored by **OFFICE Holding Ltd.** whose registered office is located at Classic House, 180 Old Street, London EC1V 9BP.

OFFICE reserves the right to modify or cancel this Competition at any time and, in the event of cancellation, substitute another in its place.

### **2. WHO IS ELIGIBLE?**

This Competition is open only to individuals aged 18 years of age or older at the time of entry, who are residents of the United Kingdom.

Employees of OFFICE and Nike, including their subsidiaries and affiliates, or of other companies associated with the promotion of the Competition, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

By entering this Competition, the entrant accepts and agrees to be bound by these T&Cs.

### **3. HOW DO I ENTER?**

The Entrant can enter the Competition on 20.02.18, at 18:00 GMT until 25.02.18, at 24:00 GMT (the “**Entry Period**”) by following the steps outlined below:

- Take a picture of yourself showing you in your Nike Air trainers
- The shot must be a head-to-toe picture
- Follow and tag @OFFICESHOES
- Use #OFFICELOVESNIKEAIR in caption and post on Instagram
- Agree to the T&Cs

### **4. WHAT IS THE COMPETITION?**

As part of the registration for the Competition, you will be required to share a head-to-toe image of yourself wearing a pair of Nike Air trainers on Instagram, following & tagging @OFFICESHOES using #OFFICELOVESNIKEAIR in the caption. (the “Entry”).

## **5. HOW WILL WINNERS BE SELECTED?**

On 26.02.18, four (4) Entrants will be selected as the winners of the Competition (the “Winners”). The Winners will be selected by and at OFFICE’s discretion.

The Winners will be notified on 26.02.18 via Instagram Private Message with instructions on how to claim the Prize via email. Each Winner must respond within 24 hours accepting the Prize or another Winner will be selected using the same method as set out above.

Decisions of OFFICE are final and binding in all respects.

## **6. WHAT CAN I WIN?**

The Winners will win an invitation to attend a styling and photography creation event in London on 03.03.18.

## **7. PRIZE RESTRICTIONS**

Winner will forfeit the prize if they are not available to attend the Event. Total approximate retail value for all prizes combined is approximately £350.

Any prize details not specified above will be determined by OFFICE in its sole discretion. The Winner is responsible for any and all other costs and expenses not listed above. Prizes will be reported as income to a Winner and the Winner is responsible for taxes, if any, associated with the receipt of a Prize.

Any difference between stated approximate retail value and actual value will not be awarded. Insurance, all expenses and incidentals not mentioned above are the responsibility of the Winner. The Winner's participation in any or all activities for the Prize is voluntary. In the event that the Winner elects not to participate in any or all designated activities for the Prize, the Winner will be afforded no additional compensation in exchange therefore.

## **8. FILM AND VIDEO RELEASE**

Entrants and Winners consent and agree that photographs, film and video will be taken of them whilst participating in the Prize or otherwise relating to the prize and any other activities or events associated with this Competition. To the maximum extent permitted by applicable law the Entrant and Winners unconditionally grants OFFICE, its subsidiaries and third party commercial partners the right to use, throughout the world and without any compensation, any photograph, video, image or likeness of them in any media including, but not limited to, television, the internet, product catalogues and brochures, point-of-purchase videos and displays, and any other printed or written material in connection therewith, for the purpose of advertising, promoting, marketing, and selling OFFICE products or promoting the Competition, the event or any other associated events.

To the maximum extent permitted by applicable law, each Entrant and Winner irrevocably grants OFFICE, its subsidiaries and third party commercial partners the unconditional and perpetual right throughout the world, without any expectation of compensation, to use each Selected Entrant and Winner's submission and other information supplied by each Entrant and Winner to OFFICE and each Entrant and Winner's image and likeness in any and all media, whether now known or hereafter developed or discovered, including, but not limited to, television, the internet, product catalogues and brochures, point-of-purchase videos and displays, and any other printed or written material in connection therewith, for the purpose of advertising, promoting, marketing, and selling OFFICE or OFFICE associate company products or promoting the competition.

## **9. INSURANCE**

Entrants understand that OFFICE does not provide any insurance, whether life or medical or liability, for any illness, accident, injury, loss or damage that may arise in connection with their participation in the Competition.

## **10. INDEMNITY**

To the maximum extent permitted by applicable law Entrants unconditionally agree to hold harmless, indemnify and reimburse OFFICE from and against any claim, sum, costs, damages or expenses (including reasonable legal fees) arising in connection with any accident, loss or damage arising out of their participation in the Competition or the Event. Entrants understand that any

liability of OFFICE relating to the Competition or Event is excluded except in case of negligence or, wilful misconduct of OFFICE or where liability cannot be excluded under applicable law.

## **11. PERSONAL DATA PROTECTION**

In order to participate in the Competition, you will supply personal information about yourself or personal information may be processed by virtue of your participation. This includes the personal data in connection with your registration and other personal data processed through the Competition itself. OFFICE will process this personal information for the purposes of administering the Competition and for the specific purposes described in these T&C's in accordance with applicable data protection and privacy law.

## **12. OTHER TERMS**

**Any violation of the T&Cs may result in disqualification. OFFICE has no obligation to notify violators of their disqualification.**

**COMPETITION OPERATIONS** In the event that the operation, security, or administration of the Competition is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, OFFICE may, in its sole discretion, either: (a) suspend the Competition to address the impairment and then resume the Competition in a manner that best conforms to the spirit of these T&Cs; or (b) award the Prize from among the eligible entries received up to the time of the impairment. OFFICE reserves the right in its sole discretion to (i) not award a Prize (if applicable) or seek the return of any Prize, or (ii) disqualify, any individual it finds to be tampering with the entry process or the operation of the Competition or to be acting in violation of these T&Cs in an unsportsmanlike, inappropriate, illegal or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Competition may be a violation of criminal and civil law, and, should such an attempt be made, OFFICE reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by OFFICE to enforce any term of these T&Cs shall not constitute a waiver of that provision.

By participating in the Competition, Entrants agree to release and hold harmless OFFICE, its parent and related companies, and their respective officers, directors, employees, and agents (the "**Released Parties**") from and against any claim or cause of action arising out of participation in the Competition or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Competition; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Competition or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the Entrants participation in the Competition or receipt or use of any prize. Entrants further agree that in any cause of action, the Released Parties' liability will be limited to the cost of participating in the Competition, and in no event shall the Released Parties be liable for legal fees. Entrants waive the right to claim any damages whatsoever.

## **13. HOW WILL DISPUTES BE HANDLED?**

These T&Cs and any disputes arising in connection thereto shall be governed by and construed in accordance with the laws of the jurisdiction of the Entrant's residence. If for any reason, a court of competent jurisdiction finds any provision or portion thereof, to be unenforceable, the remainder of these T&Cs will still be applicable and in full force and effect.
